**Treasurer Report:** Secretary/ Treasurer Cathy Moyer gave the financial report for the month of December. The Borough received income of \$5,786.92 and had expenses of \$17,563.62. At the end of 2020 the Borough had a balance of \$100,165.71 in the General Fund and \$21,483.81 in the Motor Licensing Fund. The Community Hall Fund is at \$2,500.91 and the Park Savings Fund is at \$3,819.54.

## Solicitor's Report:

Solicitor Reidlinger was not present but consideration was given to a Livestock Ordinance he forwarded to them for consideration. After some discussion it was decided to table it for further consideration at the next meeting possibly adding some stipulations for a resident to have livestock in the Borough.

#### Mayor's Report:

Police Report: Mayor George Brocious gave the police report for 2020. There were 293 calls and complaints in 2020. President Houser noted that comes to a cost of \$112.00 for each incident handled by Butler Township.

Fire Company Report: The Mayor reported that the Fire Company has been using the COVID grant in the amount of \$22,699.00.00 to purchase gear, helmets and gloves. The Fire Company also made \$1500.00 from the soup sale on December 19. He was asked if they have been hurt by not having fund raisers with the pandemic. Mr. Brocious said they may have lost \$6,000.00 to \$7,000.00 but the community has been very supportive.
