ORDINANCE NO. 63003

AN ORDINANCE OF THE BOROUGH OF GORDON CREATING CERTAIN PARKING REGULATIONS ALONG THE NORTH SIDE OF BIDDLE STREET BETWEEN MINERSVILLE STREET AND MCKNIGHT STREET AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF.

BE IT ENACTED AND ORDAINED by Council of the Borough of Gordon, Schuylkill County, Pennsylvania, and it is hereby enacted and ordained as follows:

WHEREAS, certain residential areas of the Borough are subjected to commuter vehicle parking to attend various functions in the area along the north side of Biddle Street between McKnight and Minersville Streets; and

WHEREAS, these residential areas are subjected to commuter (non-resident) traffic and parking and are deprived of sufficient spaces in which to park their own vehicles; and

WHEREAS, Borough Council has identified the residential areas deemed impacted and believes it to be in the best interest of Borough residents to provide for and establish parallel parking in these areas to ensure primary access to available parking spaces by neighborhood residents.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by Council of the Borough of Gordon, Schuylkill County, Pennsylvania, and IT IS HEREBY ENACTED AND ORDAINED by the authority of the same as follows:

1. The north side of Biddle Street between Minersville and McKnight Streets is an impacted residential area.
2. In this area, only parallel parking is permitted so as to increase the number of available spaces for neighborhood residents and to assure safety for the traveling public.

3. It shall be a violation of this Ordinance if any individual blocks, obstructs, or unreasonably attempts to reserve an unoccupied parking space by placing some form of obstruction in the street or interferes with the parking of a vehicle by any means in the area as designated above.

4. The area designated for parallel parking herein shall be for use of passenger cars, passenger vans, and pickup trucks only, and it shall be unlawful for any person to park any other kind or class of vehicle in such areas.


5. Any person who violates any provision of this Ordinance shall, upon conviction, be sentenced to pay a fine of not more than Twenty-five (\$25.00) Dollars.

6. All Ordinances or Resolutions or parts of Ordinances or Resolutions, insofar as they are inconsistent herewith, be and the same are hereby repealed.

7. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Ordinance. It is hereby declared as the intent of the Borough that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not been included herein.




