A RESOLUTION

ADOPTING CERTAIN ENVIRONMENTAL IMPACT MITIGATION MEASURES IN CONNECTION WITH THE PUBLIC SEWER SYSTEM FACILITIES OF THIS BOROUGH, AS REQUIRED BY THE CONDITIONS FOR FINANCING OF SUCH SEWER SYSTEM BY THE FARMERS HOME ADMINISTRATION.

WHEREAS, This Borough, in cooperation with the United States of America, acting through the Farmers Home Administration, United States Department of Agriculture ("FmHA"), heretofore undertook an assessment of the environmental impact of the proposed public sewer system to be acquired and constructed by this Borough (the "Sewer System"); and

WHEREAS, Such study revealed certain areas of this Borough in which future commercial or residential development, and related environmental concerns, may arise as a result of the availability of a public sewer system; and

WHEREAS, As a condition of the financing offered by FmHA to this Borough in connection with the Sewer System, it is necessary for this Borough to adopt certain measures designed to mitigate the environmental impact of the Sewer System and potential new development in certain environmentally sensitive areas of this Borough by prohibiting certain potential connections of newly constructed properties to the Sewer System in such areas.

NOW, THEREFORE, BE IT RESOLVED, by the Council of this Borough, as follows:

- 1. In accordance with the mandate of FmHA in connection with the loan and grant offered by FmHA to finance the Sewer System, this Borough hereafter shall not connect, agree to connect or permit the connection to the Sewer System of any improved properties constructed after completion of the Sewer System and located or to be located in any of the following areas of this Borough:
- a. the 100 year flood plain, as identified by the Flood Insurance Rate Map (FIRM) or other maps deemed acceptable by this Borough and FmHA for identifying such flood plains;
- b. wetlands, as identified on maps deemed acceptable by this
 Borough and FmHA for identifying wetlands areas in this Borough; and
- c. areas zoned A-1 Conservation, as identified on zoning maps deemed acceptable by this Borough and FmHA for identifying areas of this Borough zoned for conservation.
- 2. No exceptions to the forgoing connection limitations shall be granted without the express written consent of FmHA to be obtained by the owner of the improved property sought to be connected.
- 3. All other applicable land use, permitting, public health and related requirements pertaining to new development or the construction and connection of improved properties in this Borough shall remain in full force and effect.
 - 4. This Resolution shall be effective immediately.
